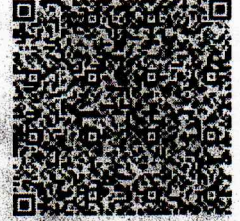

- 1) The vehicle shall be used only on a specified route.
- 2) The condition of permit shall not be departed from without the approval of the RTA.
- 3) Specified standard of comfort and cleanliness shall be maintained in the vehicle.
- 4) The MV shall be used by or on behalf of the owner for the purpose of carry persons for or in connection with his trade or business. Otherwise than for hire or reward and this vehicle shall not be used for Public purpose or required under section 2 (33) of MV Act 1988
- 5) The Permit holder / driver shall comply with all the provisions of MV Act 1988 and Rules relating under rule 70 (4) of MV Rules 1989.

## TERMS AND CONDITIONS

**VEHICLE NO. KA11B7874**

- 1) 'School Bus' must be prominently written on the back and front of every Bus carrying school children.
- 2) If it is a hired Bus, "On School Duty" should be prominently displayed.
- 3) No Bus belonging to an Educational Institution should carry children in excess of its permitted seating capacity.
- 4) Bus must have a First Aid Box.
- 5) Windows of the Bus must be fitted with horizontal grills.
- 6) There must be a fire extinguisher in every Bus.
- 7) School name and telephone number must be written on the Bus.
- 8) Doors of the Bus should be fitted with reliable locks.
- 9) Every driver of a school Bus must have a minimum of 5 years of experience of driving heavy vehicles, and must not have any previous record of traffic Offences.
- 10) To keep school bags safely, there should be space provided under the seat.
- 11) There should be an escort from the School in the Bus preferably a teacher to ensure safety norms.
- 12) The vehicle shall be fitted with speed governor which shall be maintained in good working condition at all times limiting the maximum speed to 40kmph.
- 13) The age of the vehicle shall not be more than fifteen (15) years from the date of its initial registration as on the date of entry to transport school children.
- 14) The body of school cab shall be highway yellow color with horizontal strip in green color of 150mm wide in the middle all round of the vehicle and the words "School cab" shall be prominently displayed on all four sides of the vehicle in white paint. The height of the letter shall not be less than 100 mm.



- 15) Where the age of the children being carried in the vehicle is less than twelve years, the number of children carried shall not exceed  $1\frac{1}{2}$  time the permitted seating capacity. In case of children of different ages, a person of above twelve years age shall be treated as one person.
- 16) In case of the vehicle fitted with LPG kit, the authorized LPG kit to be installed and certified by the registering authority.
- 17) No seating arrangement over LPG tank.
- 18) No tinted or colored glass permitted. Only plain white glass shall be fitted.
- 19) Manufacturers seating capacity shall not be altered.
- 20) Doors of the cab shall be fitted with reliable locks.
- 21) The driver of a school cab must have valid license to drive LMV –Transport Vehicles for period of at least 4 years.
- 22) The driver shall wear light blue shirt, light blue trouser and black shoes. His nameplate shall also be displayed on the shirt.
- 23) There shall be sufficient space provided to keep school bags inside the vehicle.
- 24) No roof carriers allowed and no bags shall be hanged on the outer portion of the body.
- 25) The name and address / telephone of the permit holder shall be painted or otherwise firmly affixed to the school cab on the rear exterior of the body in a color vividly contrasting to the color of the vehicle centered as high as practicable, below the window line in bold letters not less than 3cms in size.
- 26) Complete list of the children carrying in the school cab indicating the name, class, residential address, contact phone / mobile number, blood group and the points of stoppage for his/her embarkation and disembarkation near his/her residence against his/her name with route plan.
- 27) In case of emergency, the school cab driver/attendant shall inform the school authority about the incidence and make necessary arrangements for safety of school children.
- 28) In case of kindergarden, if an authorized person recognized mutually by the school and parents, does not come to pick the child from the halting points and such child shall be taken back to the school and their parents should be called to fetch the child.
- 29) The vehicle which is to be used as school cab shall be closed body type with hard top. No vehicle with canvas hood can be permitted to carry the children.
