

Conditions:


1. The renewal of recognition has been granted as per Right to Education Act 2009, Karnataka Educational Act 1983 and rules framed under the above laws. Classes and sections will not be added beyond what has been stated in the renewal permission.
2. The school should function as per the Right to Education Act 2009 and Karnataka Educational Act 1983.
3. As per the Rules framed under Right to Educational Act 2009, 25% seats are to be reserved for students belonging to the weaker sections of the society. Admission is provided to such students in close proximity to their place of residence. In the absence of schools private institutions are considered eligible for admitting such students. Admissions are provided for students in the absence of any nearby government schools and there should be no objections for admitting such students to your school.
4. As mentioned in condition 3 those students admitted under RTE, amount will be released by the government from time to time towards the fees of RTE students. So fees or any charges should not be collected from the RTE students.
5. The school managing committee or the school should not collect capitation fees or any amount against the will of the parents. Such collections are strictly prohibited.
6. School Adm/School should submit information regarding the fees and other charges collected from parents in the Web Site and paste the information on the school notice board as per Karnataka State section ED:31:PGC:2019, dated 7-07-2019.
- 7 School Managing Committee should make admissions in the period specified by the Government.
8. School/Managing committee should not reject admissions on grounds given below
  - (i) Completion of age specified for admission
  - (ii) Caste, Religion, Place of Birth, Language
  - (iii) Seeking admission after the last date of admission
- 9 As per RTE Act 2009 and Karnataka Educational Act 1989, school shall take all security measures (obtain approval and fitness certificate from authority with regard to

10. School/Managing Committee as mentioned below

(i) Should not detain or expel any child either in primary or middle level

(ii) Should not physically or mentally harass any child.

(iii) No child studying in primary level should be made to appear and qualify in any board exams which are not recognized by the department of Education

Karnataka

(iv) Any child who completes primary level is certified as per the provisions of RTE Act Rule 21 and Karnataka Education Act

(v) As per the RTE Act 2009 and Karnataka Educational Act, every child admitted under RTE should be treated at par with other students of the school.

(vi) Teachers working in the school should fulfill the requirement as specified in Right to Education Act and Karnataka Educational Act.

(vii) Teachers enrolled in the school should be paid salary and allowances as per the rules of Karnataka Government and contribute to P.F. and ESI as per the rules of the government.

(viii) As per the Education Act 24(1) and Karnataka Education Rules the teachers are required to discharge their duties. Conducting Private tuitions is strictly prohibited.

11 The school should follow the curriculum of the State Government and use the textbooks prescribed by the State Government.


12 As per section 19 of Karnataka Education Act the rules should be framed by the managing committee of school for appointment of teachers/staff.

13 The building of the school, other facilities and funds should not be used for political or business or non-educational purposes.


14 No person or group in the school should be involved in the office of profit.

15. The copies of audit report duly signed by the Chartered Accountant should be submitted to the BEO/DDPI every year by the end of June.
